Reservations: Rental unit reservations can be made on either a weekly or partial-week basis. Weekly stays run from Saturday to Saturday. Partial-week stays must be at least a 3-day stay that either begins or ends on a Saturday.

Deposits: A deposit is required as we hold our renters' reservations exclusively. For single rental unit reservations (whether partial week or up to 2 weeks long), \$175/week is required. For multiple rental unit reservations OR for rental unit reservations longer than 2 weeks, 50% of reservation is required.

For single campsite reservations (whether partial week or up to 2 weeks long), \$25/week is required. For multiple campsite reservations OR for campsite reservations longer than 2 weeks, 50% of reservation is required.

All deposits are due within 10 days of making a reservation. After these 10 days, we are no longer obligated to continue holding the reservation and reserve the right to re-book the rental unit and/or campsite without notice at that time.

Cancellations / No Shows: Renters are financially responsible for all reservations made with us, including no shows. Should any part of the renter's reservation need to be cancelled, notify us immediately. Cancellations will generally result in forfeiture of deposit.

Reminders:

1. All cabin/campsite rates are based on 2 people. Family house rates are based on 6 people. Extra person rates apply for all additional people.
2. Rates do **NOT** include MN sales tax.
3. All rentals require a signed rental agreement upon arrival. Failure to sign a rental agreement will result in immediate forfeiture of reservation and deposit. Also, failure to sign a rental agreement does not release renter from balance due and thus entire balance will be due immediately.
4. Balance is due upon arrival by personal check, money order, or cash as we currently do **NOT** accept credit cards.
5. **All rental units are designated nonsmoking.**
6. Check-in time is 3 p.m. or later on day of arrival. Check-out time is by 9 a.m. on day of departure. Please respect these times to allow for sufficient cleaning time of rentals. Disregard of these times will result in a half-day's stay being added to balance. No credits or refunds are given for late arrivals or early departures.
7. We reserve the right to correct any inaccuracy at any time.
